Proposed Road Closing adjoining Lot 14 in RP32805 located off Rocky Creek Road, Texas

We refer to the above matter and to your email of 24 June 2016.

Essential Energy has no objections to the proposal, however, powerlines are located within a section of the road to be closed, as indicated on the attached diagram. Essential Energy's existing overhead infrastructure is contained within part of the road to be closed. Once that section of road is closed and becomes private property, such infrastructure may not be protected. Therefore, Essential Energy requests that the easement is extended to cover the section of road to be closed.

The easement is to be created using Essential Energy's standard easement terms current at the time of registration. An easement width of 15 metres is required. Currently, reference should be made to Part A of Memorandum AG189384.

We look forward to receiving draft Section 88B Instrument and Plan for our approval.
