RENEWAL CONDITIONS (Plain English Version)

RENT

All rental payments are paid yearly and in advance at the prescribed rate. You must pay before 31 December the rental due for the following year. If you do not pay your rent by 31 December, you must pay a penalty. An extra amount - 25 percent of your rent - will be added to your rental payment. Rent and penalty must be paid by 31 March or your lease could be liable for forfeiture.

ROYALTY

Each year you will receive a royalty return form. You must complete and lodge the form by 30 September for the year ended 30 June. You may be asked to submit a royalty return at different intervals to this. For example, gold producers lodge returns quarterly.

If you do not receive a royalty return form it is then your responsibility to contact this Department to obtain a form and verify your current postal address.

You are required to calculate how much royalty is due and enclose payment with your royalty return form. Your return will be assessed and if you are owed a refund, or if a further amount is due, you will be notified. Please keep proper books of accounts and documentary evidence to support the information in your royalty return.

You must submit a royalty return even if no mining took place during the year. If you do not lodge a return you could be subject to a penalty or your lease may even be cancelled.

HEALTH AND SAFETY

To protect the health and safety of everyone on the mine site you must comply with the Mines Regulation Act 1964. Please contact the Inspector of Mines in Brisbane before work commences. You need to notify the Inspector of Mines regarding the appointment of a Mine Manager and advise the Inspector when mining operations are either due to start or finish.

CONDITIONS OF ACT AND REGULATIONS

- Maintain the marking out of the land including survey pegs (boundary posts or cairns need not be maintained after the land has been surveyed);
- Make all compensation payments and comply with all compensation agreements;
- Pay rent;
- Pay royalties;
- Deposit security;
- · Pay all local government rates and charges;
- Not spread parthenium weed seed or other weeds listed in the Rural Lands Protection Act 1985;
- Make sure your animals are restrained unless you have the written consent of the owner and have lodged the consent with the Mining Registrar and sent a copy to the Director-General;
- Not fire guns on occupied land unless you have the written consent of the owner and have lodged the consent with the Mining Registrar and sent a copy to the Director-General;


